The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

### PROFESSIONAL SERVICES

#### **Basic Services of Funeral Director, Staff & Overhead**

\$2,050

*This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials and forwarding or receiving remains). This service includes: readiness to serve (24 hours), conducting the arrangement conference, securing and preparation of certificates and permits for final disposition, completion of government forms and authorizations for final disposition and a proportionate share of basic overhead costs.*

#### **Embalming**

\$800

*Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with a viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.*

Direct Burial using Dawson Casket (Tabor Blue Cloth/Cardboard) - Blue Crepe Interior *(plus sales tax)* \$5,170

**Direct Cremation**

Includes: Basic Services of Funeral Director and Staff, transfer of remains to mortuary (within Orange County), refrigeration, cardboard cremation container, cremation process, utility urn and disposition permit. Does not include embalming, visitation or ceremony.

*If you want to arrange a direct cremation, you can use an Alternative Container. Alternative Containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering).*
